## April is Sexual Assault Awareness Month

Sexual Assault Awareness Month (SAAM) is an annual campaign to raise public awareness about sexual assault and educate communities and individuals on how to prevent sexual violence.[1] It is observed in April.

Each year during the month of April, state, territory, tribal and community-based organizations, rape crisis centers, government agencies, businesses, campuses and individuals plan events and activities to highlight sexual violence as a public health,

human rights and social justice issue and reinforce the need for prevention efforts.

The theme, slogan, resources and materials for the national SAAM campaign are coordinated by the National Sexual Violence Resource Center each year with assistance from anti-sexual assault organizations throughout the United States. For more information about LU SAAM programs, check **ENGAGE**.



## Wake Forest University student who used racial slur on video is out

A student who used a racial slur in a video is no longer enrolled at Wake Forest University, the school's president announced late Sunday.

In the video, posted on social media during the weekend, a student reportedly used the N-word and an obscenity in referring to her African-American resident adviser. The video showed a woman saying, "Let me know why I'm hammered again tonight. It's 2 o'clock ... I just called my black RA a f----- n-----. Let me know. Why did I do that?"

It's unclear whether the student was expelled or voluntarily withdrew from the university. Citing federal privacy laws, the university did not identify the student nor describe any specific action taken against her.

Wake Forest President Nathan Hatch sent a message to faculty, staff and students saying other students notified officials about what he said was "a deeply troubling video." ## Texas college students teach each other to reverse overdoses

A new network of college students is hoping to ward off a terrifying prospect: Discovering a friend, blue lipped with shallow breathing, dying from an opioid overdose.

Students at the University of Texas at Austin began learning to use naloxone, the medication often known by the brand name Narcan that rapidly reverses an overdose, more than a year ago.
